All taxes real or personal must be paid in full or the first installment paid on or before - **January 31, 2018.**

Postmarks will no longer be used for crediting payments in 2017, the payment must be in our hands by December 29, 2017. Taxes are due January 31, 2018, December postmarks are just for income tax purposes, not a property tax deadline.

If you require a Receipt, **please** enclose a **STAMPED** self-addressed envelope for a receipt to be mailed to you, otherwise **a receipt will not be mailed to you.**

A **LOCK BOX** located in the lobby of the town hall is available **24 Hours** a day. Payments may be deposited in the lock box and a receipt will be mailed, if a stamped, self-addressed envelope is enclosed.

You may pay your taxes **IN-PERSON** at the East Troy Town Hall located at N9330 Stewart School Road on the following dates:

December 2017

December 18 to December 22, 2017-- 9:00 A.M. to **1:00 P.M.**

December 27 to 29, 2017 -- 9:00 A.M. to **1:00 P.M.**

There will be NO tax collection on December 25 or December 26, 2017 and the Town Hall will be closed.

January 2018

Tuesday through Thursday -- 9:00 A.M. to 1:00 P.M.

The Town Hall will be closed January 1 and January 2, 2018.

Final Day of In-person collection will be Wednesday, January 31, 2018 till 1:00 P.M. Mailed payments postmarked January 31, 2018 will be considered timely.

Second Installments, that are due by the end of July, are payable to Walworth County and should be mailed to the County by July 31, 2018. Do Not mail or drop off your payments at the Town for that payment.

As required by the State of Wisconsin, the Town of East Troy maintains a list of persons who submit a request to receive notice of any proposed zoning action that affects the allowable use of the person's property.

If the Plan Commission completes action on any zoning proposal, and the Town Board is prepared to vote on the zoning ordinance, the Town Board shall send a notice, which contains a copy or summary of the proposed zoning ordinance, to each person on the list whose property, the allowable use of which, may be affected by the zoning ordinance. The notice shall be by mail or in any reasonable form that is agreed to. The Town Board may charge each person on the list who receives a notice by first class mail a fee that does not exceed the approximate cost of providing the notice to the person. An ordinance may take effect even if the Town fails to send the notice. (Wisconsin Statutes Section 61.35 and 62.23(7)(d)(4).)
